On 09/11/2016, I was dispatched to 705 Town Blvd (Olive Bistro) in reference to a fight call. Upon arrival, Cpl DiCicco (4202) was already on scene. Cpl DiCicco advised to start EMS to the scene and gave a description of the male. I was advised the male was last seen walking toward the LA Fitness area.

Myself and Cpl Gant canvassed the area and were unable to locate the suspect.
I then returned to the scene and spoke with the witness, Alyssa Locke. Locke advised she was eating on the patio with the victim (). Locke stated that while they were sitting there, she observed her "on and off" boyfriend Adkins, come to the location. Locke stated he walked to the area they were sitting. Locke stated Adkins wanted to speak with her and she refused to talk to him at the time. Locke stated that Adkins then walked inside and shortly after she followed him inside of the location. Locke stated Adkins had ordered a coffee. Locke stated that Adkins then walked outside to the patio area and poured the hot coffee onto and they began fighting in the parking lot area.
Locke kept stating it was her fault this incident happened. Locke stated she had told Adkins that she would give him another chance because their relationship was "complicated". Locke stated they had been dating for about 6 months or so. Locke stated she had been with for a few weeks. Locke was very hesitant at providing any information at the beginning but after speaking to her for a few moments, she provided me with her information and the information about the incident.

I asked Adkins to come back to the scene so he could tell me his side of the story. Adkins agreed to come back to the scene and returned about 15-20 minutes later.

vehicle parked in the parking lot of the shopping center. I asked Adkins if he wanted someone to get his vehicle and he asked his mother. Adkins had a friend, Winston, at the location as well. Winston agreed to take possession of the vehicle until Adkins` mother could come to the scene and get the vehicle.

Winston was also given the keys to the vehicle, sunglasses, a phone charger, and some rocks and guitar picks. Adkins had a cellphone on his person. I told Adkins he would be allowed to take his cellphone with him to the jail. Adkins` cell phone was dying so I told him I would place it on my personal charger and charge it up for him.

Before transporting Adkins, he stated his left side was hurting from the fight. Adkins was asked if he wanted to go to the hospital and stated he did not. Adkins also refused EMS. I changed Adkins` handcuffs to the front in case it was uncomfortable for him. Adkins was seatbelted in the rear of my patrol vehicle. Adkins was transported to Dekalb County Jail. Once at the jail, I secured my weapon in my patrol vehicle and released Adkins to Dekalb SO without incident. The back seat of my patrol vehicle had been checked prior to transport and after transport for contraband.

Photographs of the victim were obtained by Cpl DiCicco. The photographs were forwarded to S. Rice to be attached to the report.

After the transport was complete, I went to Magistrate Court. Magistrate Judge issued a warrant for Battery for Adkins.
